IN 2022, BIOONE COMPLETE CONTAINED 217 TITLES FROM 156 NOT-FOR-PROFIT PUBLISHERS. THE MAJORITY OF SALES REVENUE FOR BIOONE COMPLETE IS RETURNED TO CURRENT PUBLISHERS THROUGH BIOONE'S REVENUE SHARING MODEL.
